4. WHICH ARE YOUR RIGHTS?	5. TO WHOM MAY YOUR PERSONAL DATA BE COMMUNICATED?		
You have the right to <b>obtain information</b> regarding the processing of your personal data, to obtain access and copy thereof by commonly used electronic means as well.	<ul> <li>The data will be processed by appointed personnel, appropriately trained and operating under the authority and responsibility of the Data Controller. Some of the information may be disclosed to the following subjects:</li> <li>a) Dealers and/or importers having distribution and promotion agreements of MG products as well as responsibility to carry out or take care of technical assistance guaranteed by contract;</li> <li>b) Public authorities (Tax offices and other agencies);</li> <li>c) Legal or consulting firms to which the Data Controller has given a specific mandate;</li> <li>d) IT system support and maintenance companies or providers of IT storage systems;</li> <li>e) Other subjects or companies carrying out activities that are instrumental to the aforementioned purposes.</li> <li>Data may also be disclosed to group companies. These communications, carried out in the legitimate interest of the corporate group to share data and information, unify tools and procedures used in the processing, when carried out outside the European Union, are made in full compliance with all guarantees provided for by the data protection legislation and ensuring adequate safeguards for the involved person by signing specific agreements (Standard contractual clauses, Binding Corporate Rules, etc.). You have the right to obtain <b>updating, completion</b> or <b>rectification of your Data</b> .			
You can ask for the <b>portability</b> of the processed data in relation to a contract performance or to your consent.			
If you are interested, you have the right to request the <b>deletion</b> of your data.			
You have the right to request the <b>limitation</b> of the processing or to <b>object</b> , in whole or in part, to the processing of personal data concerning you.			
If you believe that one or more processing activities carried out by us may be in violation of the law, or believe that your rights have not been protected, you can lodge a complaint with the Supervisory Authority of the place where you usually inhabit, work or where the alleged violation occurred.
