**TYPE OF PERSONAL DATA PROCESSED AND PURPOSE OF THE PROCESSING**

The following personal data may be processed: personal and contact details, tax information, orders, any qualifications or certifications, bank details, economic and financial data, performance evaluation and other administrative or commercial data necessary for the purposes indicated below.



- performance of the contract of which you are a party;
- fulfilment of legal obligations, also towards the financial administration of the State;
- accounting and administrative management;
- commercial relationship management, performance evaluation and choice of suppliers as well as the management of any disputes that may arise;
- quality system management, new products development, as well as, at your request, for the management and organization of trips or transfers.

**LEGAL BASIS**

The legal basis of the processing is the performance of the contract to which you are a party, the need to fulfil the obligations provided by law, as well as the legitimate interest of the Data Controller to the management of its internal structure and organization.

The provision of the requested information is necessary to fulfil legal and contractual obligations, therefore any refusal to provide them will make it impossible to perform the contract itself or to correctly carry out all the obligations required by the indicated purposes.

**DATA RETENTION PERIOD**

Data will be stored for the period necessary for the pursuit of the aforementioned purposes and in any case not later than the terms foreseen by specific legal obligations.

**RECIPIENTS OF PERSONAL DATA**

Designated personnel, duly trained and operating under the authority and responsibility of the Data Controller, will process the data. Some information can be communicated to the recipients indicated below:

- Dealers and/or importers who have distribution and promotion agreements for Maschio Gaspardo products as well as the task of carrying out or taking care of the technical assistance guaranteed by contract;
- Public bodies (Tax Office and other entities);
- Law or consulting firms to which the Data Controller has assigned a specific mandate;
- IT systems assistance and maintenance companies or IT storage provider;
- Other recipients that carry out activities related to the purposes listed above.

The data may also be communicated to the companies of the Group. These communications are carried out in the legitimate interest of the Group to share data and information, in order to unify tools and procedures used in the processing; when carried out outside the European Union are performed in full compliance with any guarantee provided for by data protection legislation, also ensuring adequate protection for the Data Subjects by signing special agreements (Standard contractual clauses, Binding Corporate Rules, etc.).
